## A. Outside Space Rental – (electric is separate +)

1. Grand Avenue (in front of Grandstand) and Western Street.....	\$45.00 per frontage foot
2. Fairview Rd & E. Midway Circle & Wisconsin St .....	\$40.00 per frontage foot
3. Stock Street & W. Midway Circle.....	\$20.00 per frontage foot

\* ALL frontage feet must include overhangs, tie downs and trailer hitches. Concession trailers & tents are required to be **FIVE foot** back from the blacktop street. Thank for being careful of this.

## B. - Electric Rates for \*Separate for Outside space only-

20 AMP/110 Volt= **\$75.00** 20-50 AMP/240 Volt= **\$150.00** &/or 60-100 AMP/240 Volt= **\$200.00** & over 100 Amp= **\$250.00-** \*Multiple plugs into the Pole or Box are charged for each\*\*

\*For Safety & Liability ALL ELECTRICAL HOOK-UPS MUST BE DONE BY THE FAIR ELECTRICIAN

## C- Inside- Commercial tent space--"TENT Hours are-10:AM to 10:PM" (or longer if you want to)

Inside Tent Space (10X10ft) is **\$185.00** with electric & backdrops included & additional 10ft spaces: \$185.00

There are two different types of booth spaces available:

\*Manned -required to be manned during Fair Hours—or \*Display - needing to be maintained daily and you can be there some of the time if you chose to. All booth spaces look alike— just location of them differs.

Bring your own chairs, tables, displays, signs, fans, lights, extension cords, or power strip if needed for your convenience & to enhance your exhibits.

**\*\*No take down of any type until AFTER 6:PM on Sunday— Please be careful on this\*\***

Full Payment is required to reserve your location. **"NO REFUNDS"** of exhibit/concession deposits or payments is the Dodge County Fair Policy

≥Camping is available West Track side: \$150 + \$50 Elec.—all other sites \$75.00 & electrical charges of \$50 for 20AMP or applicable usage cost.

Set-UP Time begins at 8:AM, Monday with completion by 10:AM, Wednesday - "**FAIRTIME**"

**GATE CHARGES start at 8:AM on Wednesday- Tickets are REQUIRED at that time.**

Each Paid in full Rental Space receives "**Free Season Tickets**" according to size.

Additional tickets can be purchased for the Exhibitor price of \$24 each or \$6 for dailies available at the Space Managers office under the Grandstand.

Weekly and daily wristbands are available at the Fair Office & required to get back in to the grounds. Bring your tickets in to obtain the one you need.

Be sure to pick up your TICKETS FROM THE SPACE MANAGERS OFFICE at least PRIOR TO WEDNESDAY AT 8:AM - when gate fees apply. Exchange or purchase of dailies for \$6 each is possible as well. Remember your workers & delivery people; everyone must have a ticket. (or wristband)
